

## Notice of Special Town Meeting of Electors Town of Little Black, Taylor Co.

Notice is hereby given that a special town meeting of the town of little black, Taylor County, Wisconsin, will be held at the town hall located at 6022 CTh A, Medford Wisconsin on the 30<sup>th</sup> day of October 2019, at 6 PM. For the following purpose.

1. To consider the adoption of a resolution by the town meeting endorsing a town board resolution which proposes that the town levy exceed the state allowable levy limit under S. 66.0602 of Wisconsin statutes, specifically a proposed tax levy which would exceed the allowable town tax levy for 2019 before adjustments by 15.702%, for a dollar increase of \$21,714.

2. To approve the 2019 total town tax levy to be collected in 2020 pursuant to S. 60.10 (1)(a) of Wisconsin statutes.

## Resolution of Town Board to Propose Exceeding Levy Limits

Whereas, the State of Wisconsin has adopted levy limits on town, village, city and county levies for 2019 and thereafter under s. 66.0602 of Wis. Statutes;

Whereas, s. 66.0602 of Wis. Statutes limits the allowable local levy for 2019 to a percentage increase of no more than the greater of (a) 0% of the 2018 payable 2019 adjusted actual levy as calculated under the state's levy limit law\* or (b) a percentage equal to the percent change in equalized value due to net new construction; which for the Town of Little Black is 1.588 percent;

Whereas, the Town Board of the Town of Little Black, Taylor County believes that for the 2019 tax levy (collected in 2020) it is in the town's best interest to exceed the state levy limit as described above by a greater percentage than 1.588.

Whereas, the Town of Little Black 2018 payable 2019 adjusted actual levy is \$158,103. And further whereas the state law would limit the increase to \$2510 for an allowable town tax levy of \$138,286 after the reduction for personal property aid of \$22,327 before adjustments, for 2019, collected in 2020.

Now Therefore the Town Board of the Town of Little Black, Taylor County does hereby resolve and order as follows:

1. The town board supports an increase in the town tax levy for 2019 that will exceed the state levy limit.
2. The town board directs that the question of increasing the town tax levy for 2019 (to be collected in 2020) by 15.702 percent, which would increase the town levy by \$21,714 for a total town tax levy of \$160,000 shall be placed on the agenda for the special town meeting to be held on October 30, 2019.
