At that point a meeting was set for January 12 at 1 o'clock to review and establish and set fines and fees. With the uncertainty of this not being completed Bryan made a motion to table the February 6 hearing until completion at the January 12 meeting. Dick seconded. Motion carried. The committee then brought forth Chapter 90.03 ordinance High-Volume Water Use Overlay and Licensing ordinance. After review and discussion Bryan made a motion to adopt Chapter 90.03 High-Volume Water Use Overlay and Licensing ordinance. Dick seconded. Motion carried.
