

**TOWN ELECTOR RESOLUTION TO ADOPT THE TOTAL TOWN TAX LEVY
AT SPECIAL TOWN MEETING OF TOWN ELECTORS**

**Town of Little Black, Taylor County

Whereas, Wis. Stat. § 60.10(1)(a) authorizes the town electors of a town to adopt the town tax levy at a town meeting of the electors;

Whereas, a special town meeting of the town electors has been called and properly noticed to approve the 2025 total town tax levy (to be collected in 2026), pursuant to Wis. Stat. § 60.10(1)(a);

THEREFORE, the special town meeting of the Town of Little Black, Taylor County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 2nd day of November, 2025, hereby resolves and orders as follows:

The town electors of the Town of Little Black, Taylor County, Wisconsin adopt the total town tax levy for 2025 (to be collected in 2026) in the amount of \$ 225,000.

1. The town clerk shall properly post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.

**RESOLUTION BY TOWN ELECTORS TO ENDORSE THE TOWN BOARD'S
RESOLUTION TO EXCEED THE LEVY LIMIT**

**Town of Little Black, Taylor County
Resolution No. 101225**

Whereas, the State of Wisconsin has imposed levy limits on town tax levies for 2025 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602(5) allows the town electors in a town with a population of less than 3,000 to exceed the maximum allowable levy limit by adoption of a resolution at a town meeting of the town electors;

Whereas, the town board has adopted a resolution supporting an increase in the town tax levy which would exceed the maximum allowable state levy limit for the Town of Little Black; Talyor Co. Wisconsin.

Whereas, a special town meeting of the town electors has been called and properly noticed to consider the adoption of a resolution to endorse a town board resolution to exceed the state levy limits, specifically by increasing the allowable town tax levy for 2025 (to be collected in 2026) by 34.226%;

THEREFORE, the special town meeting of the Town of Little Black, Taylor County, Wisconsin, by a majority vote of the eligible electors duly assembled and voting on this 2nd day of November, 2025, hereby resolves and orders as follows:

1. The town electors of the Town of Little Black, Taylor County, Wisconsin endorse the town board resolution to increase the town tax levy for 2025 (to be collected in 2026) by 34.226% over the state's allowable 2025 levy limit, for a dollar increase of \$ 57,373. over the allowable 2025 town tax levy.
2. The town clerk shall post or publish this resolution as required by law under Wis. Stat. § 60.80(1)(a) within 30 days after its adoption.

RESOLUTION OF TOWN BOARD PROPOSING TO EXCEED LEVY LIMIT VIA TOWN MEETING

Town of Little Black , Taylor County Resolution No. 101225

Whereas, the State of Wisconsin has imposed levy limits on town, village, city, and county levies for 2025 and thereafter under Wis. Stat. § 66.0602;

Whereas, Wis. Stat. § 66.0602 limits the allowable local levy for 2025 to a percentage increase of no more than the greater of (a) zero percent of the 2024 payable 2025 adjusted actual levy as calculated under the state's levy limit law* or (b) a percentage equal to the percent change in equalized value due to net new construction less improvements removed, which for the Town of Little Black is 0.686 % (**Net new construction %**);

Whereas, the town board of the Town of Little Black, Taylor County, believes that for the 2025 tax levy (to be collected in 2026) it is in the town's best interest to exceed the state levy limit as described above by a greater percentage than 0.686 % (**Net new construction %**);

Whereas, the Town of Little Black, 2024 payable 2025 adjusted actual tax levy was 189,158, and further whereas the state law would limit this year's increase to 190,456 (Net new construction %), for a total allowable town tax levy after adjustments for 2025 (to be collected in 2026) of \$ 167,627

THEREFORE, the town board of the Town of Little Black, Taylor County does hereby resolve and order as follows:

1. The town board supports an increase in the town tax levy for 2025 that will exceed the amount allowed by the state levy limit.
2. The town board directs that the question of increasing the allowable town tax levy for 2025 (to be collected in 2026) by 34.226 %, which would increase the town levy by \$ 57,373., for a total tax levy (after adjustments) of \$ 225,000. shall be placed on the agenda for the special town meeting to be held on November 2, 2025
